What is this book all about?

FIRSTLY, WHY IT IS IMPORTANT THAT YOU READ THIS BOOKLET VERY CAREFULLY?

At Dargaville High School we endeavour to provide a broad curriculum to meet the needs of our learners on their pathway through the senior school and beyond. In the senior school the qualification system is the National Certificate in Educational Achievement (NCEA) and all subjects offer credits towards this. NCEA is a stepping stone to opportunities beyond secondary school, including further study, an apprenticeship or employment.

This handbook aims to inform students and whanau what subjects are available, the requirements needed to progress in these subjects, how they contribute to NCEA achievement, particularly which subjects contribute to University Entrance (including literacy and numeracy requirements). The handbook also includes which Vocational Pathways the assessments in each subject relate to.

The Vocational Pathways provide a framework for students to show how their learning and achievement is valued in the workplace by aligning learning to the skills needed for industry. There are six Vocational Pathways which are:

Primary Industries

Services Industries

Social & Community Services

Manufacturing & Technology

Construction & Infrastructure

Creative Industries

There are also opportunities such as Gateway, which enable qualifications to be gained in a workplace as well as in the classroom.

Read through the handbook carefully as there is a lot of information and make sure that you seek advice if you are unsure about anything. Our Careers Advisor can help with what qualifications are needed for occupations / careers as well as requirements for University Entrance and also help with scholarships that may be available to assist with tertiary study. Heads of Departments can help with subject advice and prerequisites and the Gateway co-ordinators can explain what Gateway is in addition to opportunities available in this space. The internet is also a useful source of information. A couple of useful sites are www.careers.govt.nz and www.youthguarantee.net.nz.

Finally, I encourage students and families to select pathways, and in turn subjects, that act as an extrinsic motivator in achieving success; in short, choosing subjects that you enjoy and are part of a plan.

Frequently Asked Questions

Q: WHAT SHOULD I DO FIRST?

Think about what you want to do in the future first. Check the information in this booklet to see where subjects lead to. If you are in Year 11, look at the subjects you think you would like to study in Year 13 and work backwards. Make sure you look at any pre-requisite subjects in Level 2 for subjects you will want to study in Level 3, eg if you think you will want to study Mathematics with Calculus in Level 3, you must take NCEA Level 2 Mathematics.

Make sure that you are studying the subjects that are pre-requisites for your future career and/or tertiary studies, eg: if you think you might like to do something in the field of medicine, you will obviously need to be studying Science subjects at Level 3.

Check with the Careers Advisor as to what subjects you will need. If you want to go on to University after Year 13, make sure that you will have enough credits at Level 3 and check that you meet the Numeracy and Literacy requirements. Check with the Careers Advisor, Ms Chiaroni, or your Dean, if you are not sure what you need.

Don't forget, it is also important you pick subjects you enjoy doing.

Q: WHAT SUBJECTS ARE COMPULSORY?

At Year 11 you must take a course in each of English and Mathematics and Science.

At Year 12 you must take a course in English, unless advised otherwise.

There are no compulsory subjects in Year 13.

Q: HOW MANY SUBJECTS DO I NEED TO CHOOSE?

Students in Year 11 must choose three options in addition to English, Mathematics and Science.

Students in Year 12 must choose five options in addition to English.

Year 13 must choose five subjects.

Q: CAN I MULTI-LEVEL?

Yes, there is nothing to stop you selecting subjects from Levels 1, 2 and 3.

Some subjects at a particular year level may combine credits from different levels. Check this out in the book or with the teachers. Be sure to check with your Year Level Dean that the course is appropriate for you.

Q: WHAT SHOULD I DO IF I WANT TO KNOW MORE ABOUT A SUBJECT?

Bring your parents to Academic Coaching interviews on Thursday 20th or Friday 21st September and talk to the teacher in charge of the subject.

Q: WILL ALL THE SUBJECTS SHOWN IN THIS OPTION BOOKLET BE TIMETABLED NEXT YEAR?

This will depend on how many people choose each subject. Therefore, it is really important that you choose carefully now because numbers now will determine which classes run and which don't. We will do our best but it is really up to you to select wisely.

Q: WHAT IF I WANT TO TAKE A SUBJECT THAT ISN'T OFFERED?

It may be possible to enrol with the Correspondence School or Video Conferencing. Studying by correspondence requires a great deal of self-discipline and motivation. You need to talk to either your Dean or Ms Chiaroni, if you are thinking of taking a subject through the Correspondence School or Video Conferencing

Q: WHAT QUALIFICATIONS WILL I GET?

This will depend on which subjects you choose to take. All subjects that offer credits, whether they are from Achievement or Unit Standards, count towards NCEA. Some may also lead to another recognised qualification such as a Certificate in Hospitality. The details in the option booklet under each subject will tell you how many credits you may receive.

Q: WHAT DO THE LEVELS IN NCEA MEAN?

Level 1 is the first level and is usually gained in Year 11. Level 2 is usually studied at Year 12 and Level 3 at Year 13.

To get NCEA Level 1 you MUST meet the Literacy and Numeracy requirements.

Q: WHAT IS THE LITERACY AND NUMERACY REQUIREMENT?

You must have a minimum of 10 credits in Numeracy and 10 credits in Literacy.

You will need these as part of your total of 80 credits at Level 1 to get your first NCEA certificate.

Your Literacy and Numeracy can be achieved in the following ways:

- By successfully completing assessments in a Mathematics and in an English course
- By successfully completing assessments in designated standards in certain other subjects
- By successfully completing the assessments in the specific Literacy and Numeracy standards.

Q: HOW MANY CREDITS DO I NEED TO GET AN NCEA CERTIFICATE?

Starting with the NCEA Level 1 Certificate you must achieve 80 credits. These credits must include a minimum of 10 credits in Literacy and 10 credits in Numeracy.

For an NCEA Level 2 Certificate you must achieve 80 credits. You will need to gain 60 credits from the Level 2 standards whilst the remaining 20 credits can be from either Level 1 or Level 2. To gain this qualification you must have already gained the Level 1 Numeracy and Literacy credits.

For an NCEA Level 3 Certificate you must achieve 80 credits, 60 credits of which must be from Level 3 standards. The remaining 20 credits can be from Level 1, 2 or 3.

Q: IS THERE A LITERACY AND NUMERACY REQUIREMENT AT LEVEL 2 AND 3?

University Entrance Literacy is usually obtained from Level 2 English. Some Drama and History standard also contain UE Literacy.

* Literacy 10 credits (5 reading, 5 writing) Numeracy 10 credits L1 or above.

Q: HOW WILL I ACHIEVE CREDITS?

Standards can be assessed either internally or at the end of the year by external examination. The type of assessment depends on the particular standard.

Q: WHAT IS COURSE ENDORSEMENT?

Did you know that you can now get NCEA certificates at Merit or Excellence level and subject endorsements.

Course endorsements recognise high achievers in different subjects.

To do this you must have:

- 14 or more credits at Merit or Excellence at the level that supports the endorsement: e.g. Level 1 English, or Level 2 Chemistry
 - At least 3 credits from externally assessed standards and 3 credits from internally assessed standards in that course (except for P.E., and Level 3 Visual Art)
 - Complete sufficient credits in a single school year for your NCEA.

Q: WHAT IS CERTIFICATE ENDORSEMENT?

You have gained a total of 50 credits at Merit or above overall, or 50 credits in total at Excellence.

Q: WHAT IS THE NEW ZEALAND SCHOLARSHIP?

This is an additional qualification on the Register of New Zealand Quality Assured Qualifications. It is achieved through additional examinations. These examinations are most likely to be undertaken by only very academically able students.

Q: WHAT MINIMUM QUALIFICATIONS DO I NEED TO BE ABLE TO GAIN ENTRY TO UNIVERSITY?

University Entrance (UE) will continue to be the minimum requirement to go to a New Zealand university.

To be awarded UE you will need:

- NCEA Level 3
- Three subjects – at Level 3 or above, made up of: 14 credits each, in three approved subjects
- UE Literacy – 10 credits (available from specified standards) at Level 2 or above made up of:
 - 5 credits in writing
 - 5 credits in reading
- Numeracy – 10 credits at Level 1 or above, made up of Achievement Standards – specified Achievement Standards available through a range of subjects or Unit Standards – package of three numeracy Unit Standards (26623, 26626, 226627) – all three required.

Once you have met the requirements for University Entrance it will appear on your Record of Achievement.

You must also check the Vice Chancellor's list to ensure the subjects you are taking are eligible.

Please note that some University courses have specific entry requirements. If you would like more information about specific pre-requisites for University courses please see Ms Chiaroni.

Q: CAN I ENTER ALL COURSES AT UNIVERSITY WITH THESE QUALIFICATIONS?

No. There are only a limited number of courses open to you at all universities with just these minimum qualifications.

Q: WHAT SHOULD I AIM FOR TO GAIN ENTRY TO A RESTRICTED COURSE AT UNIVERSITY?

The highest possible grades (ie: as many Excellence and/or Merit grades as possible) in a minimum of 80 credits at Level 3. Excellence and Merit grades give you a higher weighting than Achieved grades. Unit Standards only carry the same weighting as an Achieved grade in Achievement Standards. See Ms Chiaroni, if you want more information about individual University courses.

Q: DO ANY COURSES REQUIRE EXTRA FEES TO BE PAID?

Yes. Course fees are stated in the option booklet and should be paid at the start of the school year. Parents/caregivers can set up automatic payments and pay throughout the year. Field trips must be paid BEFORE the trip occurs.

Q: WHAT IF I CHANGE MY MIND ONCE I HAVE HANDED MY OPTION SHEET IN?

The actual classes that run next year will be based on your choices now. It will only be possible to change your choices if a class is running and there is space in that class for you. You must choose carefully now to have a better chance of getting your first choice. Before the end of the year you should receive a letter or the Year Level Dean will confirm your subjects for 2019.

Q: WHEN DO I HAVE TO RETURN MY OPTION CHOICES?

Distance Education and Online Learning

Distance Education occurs when students and teachers are physically separate from one another during instruction and learning periods.

DISTANCE LEARNING

Distance Learning is the desired outcome of distance education. Distance education, also known as “online learning and e-learning” refers to any learning that is undertaken by students requiring them to have a teacher or tutor from outside our school. There are currently two avenues for distance education for our students. One is through the FarNet Online Learning Community and the other one is the traditional Correspondence School. For some students the FarNet option has proven to be more engaging for the learner.

HOW DOES IT WORK?

Students, referred to as e-students, are connected to their class through a video conference bridge where they can see both their teacher and the other students in their class from schools right throughout New Zealand. Through the weekly video-conferencing session, along with the wide range of digital resources now available, students can interact with their teacher and other students. Throughout the rest of the week students work on their own on the wide range of resources but can contact their e-teacher for assistance or extra tutorials.

Ms Chiaroni, as the e-dean, provides the pastoral care of the e-students at Dargaville High School and ensures that e-students are making regular contact with their e-teacher.

FarNet belongs to the **New Zealand Virtual Learning Network Community (NZVLNC)** which means our students have access to qualified teachers in a wide range of curriculum areas from all over New Zealand.

COURSES OFFERED THROUGH DISTANCE EDUCATION

There are a wide range of courses available. They can be found on the Learning Exchange on the Virtual Learning Network - <http://pol.vln.school.nz/> The course outline and pre-requisites can be found here. The next step is to speak to the e-dean - Ms Julie Chiaroni.

WHY DO WE NEED ONLINE LEARNING?

Where possible, your child will have a teacher from our school, but to ensure that your child's learning needs are met, online learning is an excellent alternative.

Some reasons why your child may need to learn through distance learning:

1. Small class numbers at our school in a subject
2. A subject is not offered at our school
3. There is no qualified teacher in that subject or level at our school
4. A timetable clash
5. Student choice



WEEKLY VIDEO CONFERENCE CLASSES

E-students will be scheduled in a weekly class with their teacher (e-teacher) where they will be able to see their teacher and the other students in that class through the use of video conferencing.

The e-teacher will provide an internet-based online environment where resources are made available and forums set up where discussions can take place, homework can be downloaded and assessments can be uploaded. Students will no longer need to wait for their resources to arrive in the mail.

Students will have this online class on their timetable, so they will have an option line where they will be required to work independently or some supervision may be needed, depending on the student and school.

Students will need access to the internet and a device during this option line and the school will ensure this is made available. It is an advantage but not essential for students to have access to the internet after school hours.



IS ONLINE LEARNING SUITABLE FOR EVERYONE?

Our research and observations clearly indicate that this style of learning does not suit everyone .

In order for distance learning to be successful, students must:

1. Be able to work independently and to take responsibility for their own learning
2. Attend school regularly
3. Commit to attend the weekly video conference classes
4. Communicate with the e-teacher and e-dean
5. Meet the pre-requisites as stated in the course outlines
6. Gain approval from their school through the e-dean

WHAT ARE THE VOCATIONAL PATHWAYS?

The Vocational Pathways provide new ways to achieve NCEA Levels 1, 2 and 3 and develop pathways that progress to further study, training and employment. Achieving NCEA Level 2 is the foundation for success in further education and the world of work. Level 3 builds upon this through shared opportunities across school, tertiary, and industry training. The Vocational Pathways provide a framework for students to show how their learning and achievement is valued in the workplace by aligning learning to the skills needed for industry.

Dargaville High School has implemented a pathway approach to help you in your choice of subjects at Years 11, 12 and 13. The pathway abbreviations are derived from the Ministry of Education Vocational Pathways. Students are able to achieve a Vocational Pathway endorsement in addition to NCEA Level 2. The six vocational pathways are:

- C Construction and Infrastructure Sector:**
Includes vocations such as plumber, gasfitter, civil engineer, architect.
- S Services Industries Sector:**
Includes vocations such as chef, travel agent, hair dresser, retailer, fitness trainer, events manager.
- M Manufacturing and Technology Sector:**
Includes vocations such as welder, automotive engineer, boat builder, electrician, food technologist.
- P Primary Industries Sector:**
Includes vocations such as dairy farmer, forestry contractor, horticultural worker, vet nurse.
- SC Social and Community Services Sector:**
Includes vocations such as doctor, nurse, fire fighter, police officer.
- CI Creative Industries Sector:**
Includes vocations such as artist, graphic designer, actor, stage set designer, web designer.

LEVEL 2 VOCATIONAL PATHWAYS AWARD

The Award enables employers to assess more easily whether potential employees' skills align with their industry requirements.

To receive a Vocational Pathways Award, students must first gain NCEA Level 2, which is 60 credits from Level 2 and 20 credits from any other level; 80 credits in total. 10 of these credits must satisfy the literacy requirements, and 10 of these credits must satisfy the numeracy requirements. For more information about NCEA go to the NZQA website.

To get a Vocational Pathways Award, a minimum of 20 Level 2 credits must be from Sector-Related standards, with the remaining from Recommended standards to make up 60 pathway credits in total.

The Vocational Pathways Award(s) will show on a student's NZQA Record of Achievement. This is a real advantage when young people look for work and training opportunities in the sector.

COURSE DESCRIPTION:

Taratahi Agricultural Training Centre's education portfolio for schools has evolved in recent years to meet the agricultural industry's need for a skilled workforce. This new learning model encourages retention and supports contextualised learning in schools and is delivered via modular learning to expose students to a number of different sectors of the Primary Industries.

During their one day a week with Taratahi, Year 12 students will gain versatile core skills applicable to everyday life and transferable across many vocations. Whilst developing basic practical skills, there is also a focus on developing essential life skills such as independence, confidence, initiative and working as a team. Topics may include literacy and numeracy, fencing, animal welfare and behaviour, health and safety, weather monitoring, pasture management, agri-chemicals, animal feeding, equine stable skills. All modules are supported with industry guest speakers and field trips.

Cohort size is 10.

Students will spend one day per week with Taratahi on a farm learning practical farming skills. In school ONE option line is dedicated to completing the theory work required to gain the credits in the programme and for students to catch up on school work missed on their day out. As part of the programme delivery Taratahi will organise and provide transport where required.

ASSESSMENT:

Up to 20 Level 2 credits from Taratahi's one day PITA programme.

ENTRY RECOMMENDATION:

A genuine interest in the Primary Industry sector and pathway as a career choice. Entry will involve a pre enrolment interview.

Building Academy
